PRINTSHOP IS ON THE MOVE

The Printshop currently located in 'F' Dorm, will be moving to a new and larger site. It will be located in the Old Warehouse building (still in Terrace) which is the metal clad building across from the Student Parking Lot.

The reason for the move is to accommodate a proposed expansion of services by the Printshop that require more space than currently available. An added benefit will be that it is closer to the shipping point and thus allows for better productivity.

Perspective on Purchasing -

"WHAT IS AN AGENT?"

Now that we know what is needed to create an enforceable contract (Jan/96 Northwest Passages) the next issue is

Representation....What or Who is an Agent? What responsibility goes with the position?

An agent, according to the Canadian Dictionary of Law is, "One who acts for another whether for any form of remuneration or not -- includes an employee."

There are two types of agents - the formal and the implied.

The formal agent as with the College is defined by the authority issued to the position through bylaws, policies or delegation by the institute or company that employs the person. The College states in its policies that the position is the chief procurement officer and as such allows the position to have certain powers relating to the signing of contracts and the commitment of funds.

Each and every employee is an agent of the College in that there is a perceived or inferred authority to the position they occupy. Some have a higher profile than others, yet the principle is the same. This is evident during a telephone inquiry or with a customer at the counter. The person expects the server to be able to satisfy their demands (infer authority). The server is in fact acting as an agent of the College. The major difference amongst the staff is reflected in the signing authority for the spending of monies. The public expects a senior manager to have more authority than a clerk, yet, when requesting service they do not see the difference.

The area of responsibility arises from the manner in which we act on behalf of the College. If a person were to introduce themselves as an employee of the College, no authority is inferred or stated. However, if a person were to say that I run a department at the College, then it could be implied that since you run a department, hence, you must have some authority, even though you only operate a photocopier. Clear, concise information as to the limit of your authority is important when dealing with others. This eliminates any potential problems that may arise from the miscommunication. Do not end up responsible for something you had no intention of starting. Exercise caution at all times.

WHAT THE HECK IS IBT?

Have you heard the following terms lately and wondered what they mean?

IBT TCAP LEAC Education and Career Support Specialists, and; BC Benefits

All of these are related to the IBT (Institution-Based Training) Initiative of the Ministry of Skills, Training and Labour, which has had and will continue to have some very real impacts on the way we do things at Northwest Community College.

It might be helpful to understand what all this means.....

BC Benefits: This is the new name for the BC Welfare System. It refers to the benefits received by people on social assistance as well as benefits now available to the working poor of the province.

IBT (Institution-Based Training): This is one of the Ministry of Skills, Training and Labour's initiatives to assist people receiving BC Benefits to develop the skills needed to gain long term jobs. The college has been participating in the IBT initiative since the summer of 1994. The goals of the project include the following:

* improve communication between colleges and others involved in the employment of income assistance recipients.

increase participation and success rates of income assistance recipients in the post secondary education system.

* address attitudinal, systemic and financial barriers to successful post-secondary participation for students on social assistance.

* increase access to both basic education and post secondary level skill training

* improve linkages between upgrading and skill training in order to ensure "seamless" continuous movement between the elements of an individual's education and training plan.

For the first year, the main IBT project at NWCC was the Terrace Community Access Program (TCAP). This successful program provided academic upgrading, study skills, job preparation, career and educational planning, and other

employability skills to income assistance recipients. Internal college processes were also reviewed as we looked for ways to reduce barriers to access to the college: seamless transitions into other college programs from TCAP; revision of admission policies to remove artificial barriers; revised student tracking processes; improved community partnerships, especially with private training agencies and the Ministry of Skills, Training and Labour (Skills Development Division). The TCAP program was discontinued as of December, 1995 as a result of a Ministry request to broaden the scope of IBT to include all programs and all regions of the college.

Since the early fall of 1995, we have significantly expanded the IBT project. We hired three part-time Education and Career Support Specialists to help ease the transition of students into the college. These specialists serve as liaisons with MSS, MSTL, and other local funding agencies; they develop and implement strategies for removing barriers to success (such as financial costs, personal and family barriers, daycare, transportation, assistance with admissions and assessment, development of career plans, etc.); they identify "at risk" students and provide assistance to help these students continue in their training; and they provide advice and professional development for college staff to assist with student retention. The Education and Career Support Specialists provide these services for all college students, not just for social assistance recipients. At the moment, the Specialists are Jayeson Shaffer in Terrace and

Ross Hoffman in Smithers. A third position in Prince Rupert will soon be filled.

LEAC: One of the criteria for the IBT project is to set up a project planning committee. This committee, called the Learning and Employment Access Committee (LEAC), has recently been formed. It includes representation from each college region and from students, the Ministry of Social Services, the Ministry of Skills, Training and Labour, CEC, First Nations Friendship Centres, and local Anti-Poverty Societies. The LEAC will provide advice to the IBT project, ensure that we are meeting project goals, and approve requests for funding additional training spaces if the college's existing spaces are being fully utilized.

You will be hearing even more about IBT and LEAC over the next few months. One of the criteria for the project is for us to significantly expand the number of spaces available to income assistance recipients within our base budget. If we meet this criteria we will have access to ongoing funding for IBT (up to \$200,000 per year) plus the ability to apply to a Ministry of Skills, Training and Labour fund of over \$6 million to provide additional seats within the institution. This presents us with some "challenges" as we look at ways to meet these criteria, but there is also an "opportunity" to access quite a bit of money to help serve the needs for more students. It also is an opportunity for us to compensate somewhat for the expected reduction to our base funding.

THE LAW & BENEFICIARY DESIGNATIONS



"Do you Know Who Your Beneficiary Is?" Many people mistakenly believe that a will, divorce, or legal separation agreement automatically overrules any previously designated beneficiary. This is not necessarily true as described in the following "real life" legal actions.

Will vs Insurance Policy Designation

Mr. S. was married to Wife #1 for 14 years. Wife #1 has custody of their 13 year old son. Mr. S. left a will naming Wife #2, his wife at the time of his death, as the sole beneficiary of his estate. Mr. S. also had a life insurance policy designating Wife #1 as the beneficiary, which he had never changed. The court held that Wife #1 was entitled to the death benefit of the life insurance since the policy's beneficiary designation remained unchanged, even if it was not the apparent intention of Mr. S.

Even if a former husband and wife have a Separation Agreement renouncing all right to the other spouses estate, this does not waive either's right to the benefits under an insurance policy when no change is made to the beneficiary designation.

Separation Agreement vs Insurance Policy Designation

Mr. X and Ms. Y had a
Separation Agreement containing the following wording:
"It is declared that neither party has a claim against insurance policies owned by the other party and either party will execute such further assurances as are necessary to give effect to this declaration."

Before his death, Mr. X did not change the beneficiary from his separated wife, Ms. Y. The court found that Ms. Y was entitled to proceeds from the policy in spite of the provision in the Separation Agreement, as this provision was not a "declaration" within the meaning of the Insurance Act since the Separation Agreement did not identify the life insurance contract or designate a new beneficiary.

Irrevocable vs Revocable Beneficiary

In special cases, a life insured may want to appoint an irrevocable beneficiary designation, meaning that for special reasons (ie. due to the insistence of the beneficiary) the beneficiary designation is to be permanent and unchangeable. This may be done in the contract, or by a declaration (which could be in the form of a Separation Agreement) but not by means of a will. Such a declaration must be filed with the insurer at its head office or principal office in Canada during the lifetime of the person whose life is insured. Because of the seriousness of the implications, an irrevocable designation should only be made for good reason and where the insured fully understands the

consequences. For instance, the beneficiary cannot be changed without the knowledge and consent of the named beneficiary.

For all the reasons described above, it is imperative the we receive change of beneficiary designations in writing, with the policy number clearly noted and the Change of Beneficiary portion of the enrollment card duly completed.

The law regarding beneficiaries are complex and there are many more situations than those described. Seek legal advice and be sure to compare the fees of several lawyers and/or notary publics.

They also experienced hand blisters and sore arms which result from operating a wheelchair.

Various items were displayed in the main lobby throughout that week. Magnifiers, talking calculators, and specialized computer equipment were only some of the items displayed. On Thursday, Nov. 23 an "Open House", held in conjunction with C.N.I.B., was well attended by staff, students and members of the community.

The week of activities educated people on the various services NWCC provides to students with disabilities. The activities created a better understanding of the barriers individuals with disabilities face on a daily basis and illustrated the importance of ensuring an environment which facilitates life-long learning for all.

Men Can Act Together to Help Reduce Violence Against Women

My daughter cannot walk our dog where and when she wants, because of fear of violence from men. My young granddaughter, who invokes feelings of love and hope in me, will not walk in freedom if men do not act for change now.

Some people believe that only romance or sex can be the motivation for relationships between men and women. Most men fear they will lose their perceived control in romance and sex if the traditional male and female roles are altered. Romantic love can blossom where men and women are equals and friends. Partnership, not control, is the key.

Learning to relate to women as equals has doubled the number of friends I can enjoy and has opened up new intellectual stimulation, understanding of humanity and personal fulfillment. Few men are able yet to share friendship and conversation as most women can.

A lot of men have learned how to "act" toward women when required. This superficial "knowing how to act" leads to hidden resentment and confusion. As men we must learn that equality, respect, friendship and even love for a woman without romance or sex is possible and rewarding.

The horror of December 6, 1989, has caused me to conclude that just to be able to say, "I am not one of those men" is not good enough. As men who have had the good fortune to be able to truly enjoy women as close friends, we must now help them.

Men are often heard to ask, when they know of a woman being harassed, "Why did she put up with such remarks or actions?" As men, we must ask ourselves, "Why do we leave it up to our female friends to challenge men with such ignorant and disgusting attitudes?"

My December 6 commitment is this: I will seriously challenge 14 men who make hurtful, harmful, degrading remarks or actions toward women, before next December 6. I am requesting that all men who have women as close friends do the same.

Collectively, as men we are the problem. Collectively, as men we must become the solution.

I make this commitment with the hope of increasing male support for all women, and in respect for my loving wife, without whose understanding I would be incapable of offering support
